## DMAP (Deer Management Assistance Program) Online and Mobile Harvest Reporting Instructions

DMAP harvest reporting will include all tags issued through the North Carolina's 3 DMAP programs: 1) traditional <u>Deer</u> <u>Management Assistance Program (DMAP)</u>, 2) <u>Community Deer Management Assistance Program (CDMAP)</u> or 3) <u>Chronic Wasting</u> <u>Disease Management Assistance Program (CWDMAP)</u>.

DMAP permits and tags are issued to business entities which include: hunt clubs, farming businesses, homeowner/property associations, and corporations (see DMAP participant information requirements document for further information and requirements). Tags are distributed to individual hunters at the discretion of the permit holder.


DMAP harvest reporting will now be using the new Go Outdoors Carolina licensing system. This system provides 3 harvest reporting options for hunters to report their DMAP harvests: 1) online reporting (<u>GoOutdoorsNorthCarolina.com</u>), 2) mobile app (available for iOS and Android from your app store), and 3) telephone (800-I-Got-One [800-446-8663]) reporting options. 
You will receive an Authorization number when you have completed the harvest registration. This number must be retained by the hunter to legally possess their harvest.

As proof of registration, your harvest registration details can be seen on your 'Harvest Reports' page. If applicable, past harvest authorizations can also be found on your Go Outdoors North Carolina mobile app.

## 2. Using the Go Outdoors North Carolina Mobile App reporting option:

Open the 'Go Outdoors North Carolina ' app. Select the *Deer Head icon* at the bottom of the screen. Select 'DMAP Tag Reporting'.

You will be required to enter and lookup the "Tag #" and the business "PIN" which is printed on your DMAP tag. Each tag can only be used once. If the tag is successfully found in the system, complete the following harvest questions, then push 'Submit'.



Before the coming hunting season, you will be contacted by a district biologist to review your request. Your application will go into 'Pending' status during this time and show under your "Current Licenses & Permits". You may check on the status of your application by clicking on "Customer Applications" tab located on the Home page.

DMAP packages will be mailed in August. DMAP packages include your final authorization permit, tagging/reporting instructions, and associated deer tags. If you have any further questions, call our wildlife management office for assistance at 919-707-0050 during normal business hours.
