1. Please print or type this form.
2. **Name, WRC customer number, preserve name, CFP license number, telephone number, email address** - Pertaining to individual listed on the license.
3. **Species** – Gray fox, red fox or coyote; each species shall be recorded in a separate row
4. **Date** - List the date of that species was released into or removed from the preserve. This includes purchases and transfers.
5. **Number.** - List the number of specimens trapped by species
6. **County of Capture** – List County where the animal was trapped.
7. **Information of Transferee** – Provide the applicable license number for the license holder from which the CFP acquired the species from or for which the CFP transferred the species to.
8. **Transportation Permit Number** – List transportation permit number, if applicable.
 - Individuals transporting live foxes and coyotes to or from a licensed CFP shall have a valid transportation permit.
 - Individuals transporting live foxes and coyotes on behalf of a licensed CFP shall have a valid transportation permit or a copy of the operator's current CFP license.
9. **Comments** - As specified.
10. **Certification** - Signature is required for report acceptance and license renewal.
